



A. GENERAL

1. The promotion is offered by Blueberry Markets Group (**Blueberry Markets**). Blueberry Markets is a registered domain of Eightcap Global Ltd (Company No.: 40377), a company providing trading in financial and commodity-based derivative instruments and other securities and which is authorised and regulated by the Securities Commission of the Bahamas (the "SCB") (SIA-F220). This promotion is exclusive to selected clients (**Selected Clients**). Selected Clients are those who meet the additional Criteria listed below.
2. The promotion shall commence on **29 March 2022 (Commencement Date)** and is available until **29 March 2023 (Promotion Period)**. Any claims or requests made before the Commencement Date will not be eligible for participation unless specifically approved by Blueberry Markets.
