



A. GENERAL

1. The promotion is offered by Blueberry Markets ("Blueberry Markets"). **Blueberry Markets** is an authorised representative of ACY Capital Australia Limited, a company providing trading in financial and commodity-based derivative instruments and other securities and which is authorised and regulated by the Vanuatu Financial Services Commission (the "VFSC"). This promotion is exclusive to selected clients (**Selected Clients**). Selected Clients are those who meet the additional Criteria listed below.

2. The promotion shall commence on **1 December 2022** and is available until **30 April 2023 (Promotion Period)**. Any claims or requests made before the Promotion Period will not be eligible for participation unless specifically approved by Blueberry Markets.

B. CRITERIA

3. To be eligible for this promotion, Selected Clients must:
 - a. open a live trading account (**Account**) with Blueberry Markets;
 - b. not have made an Initial Deposit before the commencement of the Promotion Period, and
 - c. make a minimal Initial Deposit of \$200 (or its equivalent in the Selected Client's Account Base Currency on or before the end of the Promotion Period.

6. The accrued losses are deemed valid if the trading account is at a total loss for the month of February

The Refund:

- a. Will be processed by Blueberry Markets on 04 May 2023;
 - b. May take up to 24 business hours to be added to the Selected Client's Account;
 - c. Can be withdrawn as cash.
7. Real Equity on a Selected Client's Account is available for withdrawal at any point in time.
 8. A Selected Client may withdraw their Original Deposit at any time, provided their Original Deposit has not been lost in the course of their trading activity or is being used as margin.

Net Equity means the account balance including (after) any unrealised profit and/or unrealised loss on open positions. Net Equity is an indication of the overall performance of an Account as it considers the Account balance and how each individual position is performing.

Original Deposit means the amount of money initially deposited by you to participate in this Promotion and any further deposits made by you in accordance with clause 3 of these terms and conditions.

Real Equity means the Net Equity of the account.

Refund Means the amount deposited by us into your account as per the table shown in section C of these Terms and Conditions.
